#### 4. FINANCIAL RESULTS

4.1. The Financial Results up to 30 March 2006 were circulated. It was agreed by the Committee that only Form 1 would be distributed at the Annual Assembly.

#### **ACTION DT**

- 4.2. Commenting on the results DK reported that there was an underspend of £6900 for the year. It was also noted that £17000 from existing reserves would be used to support budget 2006/7.
- 4.3. It was reported that the RFO had not made a claim for VAT repayment in 2005/6 until the year end, instead of each three months as had been done last year. The effect of this had been to adversely effect cash flow to a serious degree. It would appear that the reason for this was due to oversight by RFO. There was also some debate over the VAT rules for Parish Councils and the process requirements to ensure VAT returns were submitted.

4.4. The Committee agreed unanimously that all regular grants would be paid after receipt of the precept.

4.5. The Committee agreed that a prize for the community be given to both the villages primary schools.

#### 5. 2006/7 CONTRACTS AND PROJECTS

5.1 The Committee agreed to the retention of Kent County Council for grass cutting in King Georges Field and Five Ashes as per the following schedule.

#### **ACTION DT**

5.2 A further estimate and proposal for the agreed bicycle racks was debated. The Committee decided to implement a twelve station cycle rack (BR12GF) from Wybone at a cost of £144.39 + VAT and fixings.

The Committee decided that the cycle rack would be placed behind the shelter, near the pre school on King Georges Field. The structure to be secured on a concrete base.

#### **ACTION DT**

#### 6. LIGHTING COSTS

- 6.1. DT reported the current position with regard to maintenance charges which were that EDF energy had advised that prices would be held until March 2007. The cost of 2006/7 was £2916.
- 6.2. Problems notified 2 at Queensmount.

Repairs carried out – No 19 Coggins Mill Lane and No 65 Mayfield High Street.

6.3 DT advised that the estimate for the proposed new light at South Street car park was £809.34 + VAT. The Committee wished to be reassured that the proposed light would blend into the surroundings since it was an area of natural beauty.

### 7. ELECTRIC BLANKET TESTING

7.1. It was reported that WDC would not be able to include Mayfield and Five Ashes in the October 2006 for electric blanket testing. However WDC had offered to collect the blankets from a central point and test them at Crowborough. The Committee resolved to decline the offer since it would cause considerable logistical problems.

#### 8. YOUTH ACTIVITIES

- 8.1. DK reported on the Youth Group drop-in centre's progress. It was agreed that the Youth Group membership would attend the session to be held on Monday 22 May 2006 at 1900 hours after which the F&GP meeting would be held at 1930 hours.
- 8.2. It had been agreed a further meeting of the Youth Group would be held, at which representatives of the village youth would attend this meeting and would start at 1700 hours at a date to be decided.

#### 9. DOCUMENTATION

9.1. Reserves Statement – With one amendment the Reserves Statement was accepted by the Committee and is attached to the minutes.

- 9.2. The Financial Regulations had been amended and will be re-issued in time for the AGM.
- 9.3. DT reported that the insurance renewal had been received and checked and is in order. The Committee approved the payment of the premium of £2660.

- 9.4. The notice of external audit had been received, and the process for completion was agreed.
- 9.5. It was necessary to prepare the internal audit for 2006/7, and it was agreed to raise this issue at the next meeting.

#### 10. CALOR VILLAGE OF THE YEAR COMPETITION

10.1. It was reported that the application for the Village of the Year competition had been received. After debate it was agreed that the issue would be raised at the next council meeting and that consideration be given to Five Ashes entering the competition.

- 11.1. DT reported the current position with regards the location of the Mayfield and Five Ashes Parish Council Deeds and Records. This was:

  - Enquiries to be made with ESCC, Norman Bennett and Nat West Bank.

#### **ACTION DT**

11.2. HH reported a number of trees located on Kings Georges Field and the Memorial Hall area needed to be examined for safety. These would be inspected on Thursday 27 April and a report submitted.

11.3. Following debate on the proposed seat for Fletching Street the Clerk was instructed to progress with WDC before progressing fully to completion.

#### **ACTION DT**

11.4. King Georges Field gates were to be equipped with bollards and gate stops. The Clerk to arrange as soon as possible.

11.5. It was noted that the King Georges Field Charity Commission return may be required and that this should be taken into account when the charity accounts are prepared.

11.6. The Clerk had received correspondence from Mr Hamish Bowerman claiming payment for work on the King Georges Field. The Committee ruled that their decision to cancel this arrangement in January 2002 still stood, and the Clerk should inform Mr Bowerman.
