MINUTES

1. DECLARATION OF INTEREST BY MEMBERS ON AGENDA ITEMS

1.1. There were no declarations of interest by members on agenda items.

2. MINUTES OF MEETING 21 NOVEMBER 2011 (11D05)

2.1. It was noted that the minutes were approved by the Full Council at the December meeting.

3. SKATEBOARD PARK

- 3.1. Rhys Jenner of Southmead Close made a presentation to the Committee on ideas to redevelop the skateboard park (see Annex 2), drawing on experience of skateboard parks in Crowborough, Flimwell, Jarvis Brook and Heathfield. The difference between wood and other construction methods were described.
- 3.2. The advantages of the Mayfield location, and its lack of social undesirables was explained as was the need to try and segregate the younger skateboarders from the more experienced.
- 3.3. JD and DR explained the financial position of the Parish Council noting that for any large scheme it would be necessary for the group to help with funding. Various grant opportunities outside the reach of the Parish Council were discussed.
- 3.4. The following actions were agreed:
 - RJ to develop plan for skateboard park with outline costings.
 - DT to check whether planning permission is needed.
 - DT to advise RJ of grant opportunities.
 - DT to highlight in Yellow Pages.
 - DT to adviseJanet Stead and the Youth that they might support the project
 - MAFAS to be advised.

4. YOUTH REPORT

- 4.1. JS and KD reported as follows:
 - Group currently composed of girls.
 - Outdoor activities undertaken.
 - The Group were making video diaries.
 - Disco event.
 - Website links.
- 4.2. With regard to carrying out volontaryl work for the village JS had doubts about the practicality of the idea, however she would suggest taking part in the Jubilee event.
- 4.3. It was felt that coverage in Yellow Pages would be useful. Clerk to arrange.

5. COURT MEADOW PLAY AREAS AND BOUNDARIES.

- 5.1 The proposal to fit the play areas in Court Meadow with shredded rubber matting was discussed and would be reviewed when costings were received.
- 5.2 It was noted that dog fouling had reduced in Court Meadow of late, however, it was considered that a dog bin should be placed in the High Street. JD to advise location.

5.3 With regard the boundary issues it was reported that the boundary for Bluebell cottage was in the hands of the solicitor, but also there could be a possible incursion at Rock Cottage which the Clerk was taking up with the solicitor and Wealden District Council.

6 JUBILEE BEACON

- 6.1 The Clerk reported that St Dunstans Church had raised the issue of beacons and that the Vicar had suggested putting one on the Church Tower roof.
- 6.2 After discussion it was agreed that the Clerk would progress the matter and obtain costings. Brian O Connor would be asked to research whether historically Mayfield had lit beacons.

 - It may therefore be possible to attain the addition of Village Green status. The Committee had been looking at charity status and covenants to give further protection and may be able to give a final recommendation before too long.

ANNEX 2

REASONS WHY WE WOULD LIKE TO INCREASE MAYFIELD SKATE PARK

The skate park is very important to Mayfield because it keeps kids entertained. It also encourages kids to start up fast growing sports such as skating, scootering, BMX'ing and skateboarding.

More and more kids are starting to use it and at busy times its too small for the growing number of people using it.

Ramps are not really big enough for the more experienced users.

When big and small kids using it there are sometimes accidents.

Mayfield skate park has people who only want to go there to use the park not just hang around loitering. In Crowborough and Heathfield lots of kids just hang around there so some people come to Mayfield from Heathfield and Crowborough because of this.

IDEAS

Increase the size of the park and have the new part aimed for more experienced users, this would give everyone more room to use the park at their own level.

Solar powered street light to come on when it gets dark so in the winter we can use it past 4-5pm. This could be on a timer to go off at say 8pm so it doesn't encourage misuse of the park.

To help pay for it we could get people to put adverts on the backs and side of the ramps.
