1. Apologies for absence

1.1. There were no apologies for absence.

2. Declaration of substitute members

2.1. There were no substitute members.

3. Declaration of interests on agenda items

3.1. There were no declarations of interest.

4. Public questions and comments

4.1. There were no public questions.

5. Minutes of the meeting of 27 June 2018 (previously adopted)

5.1. The minutes were reviewed and the actions list updated.

Matters arising from the minutes:

- 5.2. The landowner of footpath FP55 where the vegetation is overgrown has informed that it will be cut back in November this year.
- 5.3. FP79 is still blocked by vegetation at the A267. A reminder will be sent to ESCC with a request for them to install a sign at the opposite end to inform walkers that it is impassable. **Action JT**
- 5.4. The broken dog latch on FP15 has been reported to ESCC however there is an adjacent gap so it is not obstructing the path.

6. Trees Report

- 6.1. There have been several planning applications for tree work that have been approved by WDC.
- 6.2. There has been a complaint about the safety of a mature tree in Station Road that abuts the boundary of a residence in West Street. The WDC Tree Warden has been requested to assess the situation.

7. Volunteer maintenance team report (previously circulated)

- 7.1. The work programme was reviewed and updated.
- 7.2. The steps at the corner of the football field have been built up.
- 7.3. The wobbly stile on FP46 has been repaired.

- 7.4. There was an attempt to install the memorial bench in Court Meadow however the bench fixings are inappropriate to install on grass. An alternative location will need to be considered.
- 7.5. There has been additional clearance work on FP55 towards Fletching Street.
- 7.6. The Jacobs Ladder on the circular walk is in need of repair.

Newly reported items:

- 7.7. There is overgrown vegetation on FP47 near Pennybridge Lane that will be reported to the landowner.

- 7.8. There is a broken stile on FP30c on the Southern edge of Ashurst Wood (asset number S0928).
- 7.9. There have been horse riders using the footpath from the old furnace noticeboard to Coggins Mill Lane. Waymarkers have been recently installed to make the nearby bridleways more obvious.
- 7.10.BW38c off Tidebrook Road is very overgrown on one side with barbed wire on the opposite side that will be reported to ESCC. **Action JT**
- 7.11. The bridleway to Bassetts Lane from Tunbridge Wells Road has been recently cleared by ESCC as well as the road from the windmill to Bycycle Arms at Argos Hill.

8. Diversion of footpath 3 (information previously circulated)

- 8.1. The Committee looked at the proposed diversion in March 2016 and there were no objections raised at the time.
- 8.2. This decision has been forwarded to ESCC with comments that in general it is not considered appropriate to divert footpaths that have been in situ for many years.

9. Stiles on FP69e (information previously circulated)

- 9.1. A report on the missing stiles on FP69e from ESCC was circulated.
- 9.2. They have advised that although the stiles are missing the landowner has provided sufficient room for walkers to pass. The missing stiles have therefore been removed from their asset list.

10. Mayfield circular walk publication (information previously circulated)

- 10.1. The circular walk leaflet was previously printed in 2011 and is out of date.
- 10.2. The Committee agreed it is a very well used walk and should be republished.
- 10.3. Enquiries will be made into the original artwork.
